SPONSOR TERMS & CONDITIONS

I. Compliance

Sponsor shall abide by and observe all laws, rules, and regulation of the program venue. Sponsor shall observe and abide by additional regulations made by SNDA for the efficient and safe operation of the program.

II. Force Majeure

If SNDA should be prevented or materially affected from conducting the program, SNDA will refund the applicant the amount of the fee paid with no further obligation or liability to the applicant. In all circumstance, SNDA shall notify the sponsor at the earliest date possible of the circumstance affecting their participation.

III. Indemnification

Sponsor agrees to indemnify, defend, and protect SNDA against, and hold and save SNDA harmless from, any and all claims, demands, suits, liability, damages, loss, costs, attorney fees, and expense of whatever kind or nature (collectively "claims") which might arise out of (i) any action or failure to act of the applicant or any of its officers, agents, employees, or other representative; (ii) damages or loss to property, or injury to the person or any property of the applicant, any of its officers, agents, employees, or other representatives, or any third party; and (iii) all claims relating to or arising from patent, trademark, or copyright infringement, subcontractor and/or agents. In addition to the duty of the applicant to indemnify, SNDA shall also have the right to terminate this agreement if a claim arises during or prior to the SNDA 53rd National Convention.

IV. Liability

Sponsor assumes all responsibility for any and all loss, theft, and/or damage to sponsor's displays, equipment, and other property while at the program, and hereby waives and all claims and/or demands it may have against SNDA from such loss, theft, and/or damage.
